How We Store Your Personal Information

Your information is securely stored.

We keep contact details for five years. We will then dispose of your information by undertaking an annual erasure from our databases.

Your Data Protection Rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.
